MINUTES

- 1. Call To Order.** Supervisor Sellers called the meeting to order at 5:30 P.M
- 2. Pledge of Allegiance** was recited and roll call was taken as follows:
- 3. Roll Call.** Members present were as follows: Trustee Nickee Bender, Trustee Joy Sellers, Trustee Kathi Altensey, Trustee Mickey Martin, and Supervisor Patrick Sellers. Also present were Assessor Cynthia Petta Connell and Attorney Michael J. Phillips.
- 4. Approval of Minutes of the October 17, 2016 Town Board Regular Meeting.** A motion was made by Trustee Altensey and seconded by Trustee Sellers to approve the minutes from the October 17, 2016, Town Board Regular Meeting. A voice vote was taken and Supervisor Sellers declared the motion passed and the minutes were approved.
